- Urban Humanities: New Practices for Reimagining the City, collaboratively authored with Dana Cuff, Anastasia Loukaitou-Sideris, Maite Zubiaurre, and Jonathan Crisman (Cambridge: MIT Press, 2020), 336 pp. At the intersection of architecture, urban planning, and the humanities, this book explores methods and practices for engaging with cities and imagining new possibilities for spatial justice. Urban Humanities argues for an interdisciplinary approach to studying cities and introduces methods such as thick mapping, filmic sensing, and speculative design into contemporary discussions of urbanism.
- Probing the Ethics of Holocaust Culture, edited by Claudio Fogu, Wulf Kansteiner, and Todd Presner (Cambridge: Harvard University Press, 2016), 528 pp. This edited volume is a reappraisal of the debates and controversies that have shaped Holocaust studies over a quarter century. With twenty chapters, four introductory essays, and an epilogue, the volume brings international scholars of the founding generation of Holocaust studies into conversation with a new generation of historians, artists, and writers who have challenged the limits of representation through their scholarly and cultural practices. Organized around three interlocking themes—the stakes of narrative, the remediation of the archive, and the politics of exceptionality—the essays in this volume explore the complex ethics surrounding the discourses, artifacts, and institutions of Holocaust remembrance.
- HyperCities: Thick Mapping in the Digital Humanities, with contributions by David Shepard and Yoh Kawano (Cambridge: Harvard University Press, 2014), 212 pp. This book examines the field of digital cultural mapping and asks how qualitative and quantitative approaches to spatial analyses can foster Humanities scholarship. It does so by tracing the media and technological genealogy of the HyperCities platform, referencing key conceptual antecedents in the field of hypermedia information visualization, the history of the geospatial web, and the textured field of the Digital Humanities. - Digital\_Humanities, collaboratively authored with Anne Burdick, Johanna Drucker, Peter Lunenfeld, and Jeffrey Schnapp (Cambridge: MIT Press, 2012), 141 pp. Arguing for the deep and precarious linkage between the "humanities" and the "digital," this book examines the emerging forms, genres, and social life of the Digital Humanities. It is a vision statement for the future, an invitation to engage, and a critical foundation for understanding collaborative, digitally-inflected, generative approaches to the Humanities within the academy and in society-at-large.
- Mobile Modernity: Germans, Jews, Trains (New York: Columbia University Press, 2007), 368 pp. This book argues for the profound interconnectedness between German thought and Jewish thought and is staged as a series of "stops" on a railway itinerary through German-Jewish history. The railway not only serves as the methodological organizing principle for the book but also represents the dialectic of German/Jewish modernity, both the hopes and catastrophes at its core.

- Muscular Judaism: The Jewish Body and the Politics of Regeneration (New York/London: Routledge Press, 2007), 279 + xxiv pp. (Paperback edition, 2010). This interdisciplinary work of cultural history examines the birth and popularization of the "muscle Jew": the strong, healthy, nationally-minded Jew. Traversing sports history, medical literature, popular culture, aesthetics, gender studies, colonialism, and military history, the book weaves together the story of the regeneration of the Jewish body in light of other European discourses of regeneration, which sought to bring about the rejuvenation of nation, spirit, and body.
- Lead translator of a collection of essays by Reinhart Koselleck, *The Practice of Conceptual History: Timing History/Spacing Concepts*, Foreword by Hayden White (Stanford: Stanford University Press, 2002), 363 pp. Koselleck was one of Germany's foremost philosophers of history, known for his contributions to the study of historical concepts.

### Books-in-Progress:

- Ethics of the Algorithm: Holocaust Memory, Big Data, and the Future of Testimony (currently under review, 145,000 words). This book employs a wide-range of computational methods from natural language processing to machine learning to ask new questions of Holocaust history and memory. The book starts with a reexamination of the earliest, proto-computational approaches to studying Holocaust testimony in the 1950s, and it concludes with an examination of contemporary, AI-driven testimonies that use machine learning to process responses to questions. In between, it delves into thousands of testimonies and witness accounts from various corpora (the USC Shoah Foundation, the US Holocaust Memorial Museum, the Yale Fortunoff Archive, among others) using digital humanities and computational approaches focused on the analysis of language, sound, performance, and narrative. Richly illustrated with visualizations, data narratives, and interface designs, the book ultimately asks what it means for algorithmic methods of analysis to be ethical and how they can complement humanistic interpretations and values.
- A Message in a Bottle: The Ethics of Testimony from an Archive of the Future (writing in progress). Taking its title from Paul Celan's idea of a poem as a "Flaschenpost" (message in a bottle), this book focuses on the analysis of a unique archive of Holocaust letters and sketches that were written days and sometimes even hours before the death of the author. They were hidden often buried in bottles -- and discovered after the Holocaust. The book asks what it means to bear witness in situations of extreme violence and destruction when nearly all traces of testimony are absent. Using an interdisciplinary conceptual framework built on the literature and philosophies of Walter Benjamin, Emmanuel Levinas, Toni Morrison, Saidiya Hartman, and others, the project investigates the idea of writing blindly on the edge of death, the attempt to communicate to the future, the silences and voices of the archive, and the ethical imperatives of being open to the message of the wholly other.
